



**INVITATION FOR BIDS 2026 (IFB 01)**

**RURAL ROAD DEVELOPMENT PROJECT**



1. The Chairman, Regional Procurement Committee (RPC), on behalf of the Divisional Secretariat, Vadamaradchy South West, invites sealed bids from eligible and qualified bidders for the works described in the table below. The relevant details are provided in the table below.
2. Bidding will be conducted through the **National Competitive Bidding (NCB)** procedure.
3. To be eligible for contract award, the successful bidder shall not have been blacklisted and shall be registered with the **Construction Industry Development Authority (CIDA)** in the field of road construction under the grade specified in the table below.  
**“Bidders shall also register themselves with the Registrar of Public Contracts, Sri Lanka, in terms of the public Contract Act No 03. of 1987 if the contract amount exceeds Rs.5.0 million”**
4. The qualification requirements are specified in **Section 4** of the Procurement Document. Additional details are provided in the **Bidding Data** and **Contract Data** of the **SBD 1** document.
5. Interested bidders may obtain further information from the address given in Clause 6 and inspect the Bidding Documents at the same address on working days from **06.07.2026 to 20.07.2026**, between **9:00 hrs and 15:00 hrs**.
6. A complete set of Procurement Documents in the English language may be purchased by interested bidders upon submission of a written application to the **Chairman, Regional Procurement Committee, Divisional Secretariat, Vadamaradchy South West, Karaveddy**, during the period specified in the table below, between **9:00 hrs and 3:00 hrs**, upon payment of a non-refundable fee of **Rs. 5,000.00**. Payment shall be made in cash.
7. Bids (Original and Duplicate) shall be delivered by hand or sent by registered post to the **Chairman, Regional Procurement Committee, Divisional Secretariat, Vadamaradchy South West, Karaveddy**, on or before the date and time specified in the table below. The bid number shall be clearly marked on the upper left-hand corner of the envelope. Late bids will be rejected. Bids will be opened immediately after the closing time in the presence of the bidders' representatives who choose to attend at the **Divisional Secretariat, Vadamaradchy South West, Karaveddy**.
8. Pre-bid meeting will be held at the **Conference Hall, Divisional Secretariat, Vadamaradchy South West, Karaveddy**, on the date and time specified in the table below.

9. Procurement Committee will keep right to make final decision in regard to accept or reject bid.
